



The civil defence shelter accommodates 250 people and is equipped with an air filtration system and power generating units. It also has medical supplies, water, and food



How to buy property at the auction?



- The privatisation object comprises a single property complex of a state-owned enterprise.
- The buyer becomes the legal successor to all property rights and obligations of the enterprise, except for the right to permanent use of the land plot.
- The buyer is responsible for settling the enterprise's previous liabilities, including wages and budget payment obligations.
- Additionally, the buyer must retain the jobs of the enterprise's employees for six months from the date of acquiring ownership

- The buyer is required to take measures to terminate the legal entity.
- The starting price excludes taxes; the final sale price is subject to VAT
- The auction winner forfeits the guarantee fee in case of refusal to sign the auction protocol, failure to conclude the sale and purchase agreement, or failure to pay the sale price of the privatisation object
